On August 16, 2023, Tim Brackney notified Resources Connection, Inc. (the "Company") of his resignation as President and Chief Operating Officer of the Company effective October 1, 2023. The Company is evaluating its organizational structure and expects to appoint one or more individuals to succeed Mr. Brackney and assume his current responsibilities on a permanent basis.
